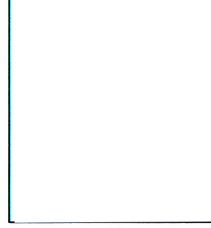

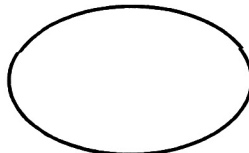

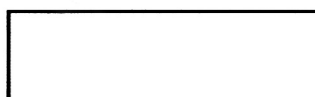

### Rules & Regulations WHRC

1. The above mentioned particulars/details/ information are true to my personal knowledge and belief.
2. To do hereby declare that before the date of signing this application I have neither been convicted so far. Also there is no adverse report is lodged against me in any Police station anywhere in India. There is no case of any nature pending in any Court of Law.
3. I am fully conversent that membership fees once deposited is not refundable nor it will be adjusted against any due. In case any conviction or consequent of taking any adverse action by any authority in connection with any offence. I shall have no right to claim Membership fees and it will stand forfeited.
4. In case under the direction of President of State, District and/or City could not achieve the target of making members of the association, within a period of two months such president may be removed from the post of president, which will be acceptable to us.
5. Travelling/visit to any place(s)/Govt. office(s) /meetings/Demonstration/Agitations/ gates meetings propogandas/discussion on revolutions of Headquarters and it will be necessary to information to the president of state.
6. Any kind of misbehavior or misconduct may result in rejection of membership of WHRC. All disputes subjects to jurisdiction of Mumbai only.
7. WHRC will not be responsible for any misuse of identity card issued to the members during the hcourse of their membership with WHRC.

9. Only the National President has the authority to issue the card. If otherwise, the offender will be prosecuted according to Indian Panel Court.
10. Strict action will be taken against the Member, if found guilty floating the rules and regulations of WHRC and are also punishable under the Press & Societies Act.
11. The Members and Officers of WHRC are working on voluntary basis and no payment is given to them. Membership is non-transferable and once the payment is made, it is non-refundable.
